### Definitions:


Sector: All early years and childcare settings (0—5 years)

Workforce: Anyone working or volunteering within the early years sector,

in any role







Early Years and Childcare Support (EYCC) offers information, support, challenge, and training opportunities to all early years and childcare providers within Lincolnshire. This includes Schools, Pre-Schools, Nurseries, Day care Settings, Registered Childminders and Out of School Clubs.

The government places the duty on the Local Authorities to ensure there is sufficient, accessible, and affordable childcare available to support families to access work or training. In addition ensure that all eligible children are able to access their <a href="Early Years">Early Years</a> <a href="Early Years">Entitlement</a> (EYE). In April 2017, the government introduced a new early years National Funding Formula this sets out the hourly funding rate that each Local Authority is paid to deliver the universal and additional entitlement for 3 and 4 year olds.

Following this in September 2017, the government introduced the extended entitlement, doubling the amount of <u>free childcare</u> from 15 to 30 hours a week for working parents of three and four year olds. The intention is for the 30 hours extended entitlement to have a real impact on the lives of families, supporting parents who wish to work, or to work more hours, if they wish to do so.

This has required capacity planning across Lincolnshire, especially for areas where childcare providers have maximised places.

The Early Years and Childcare Support team continue to monitor the market place and support providers to offer additional places where any sufficiency gaps are identified. There is a team of Development consultants available who will work with the sector to address the needs of local families.

All Local Authorities are required to establish an SEN inclusion fund following the introduction of the revised funding formula this is to give top up grants to providers to support the county's most vulnerable children. As part of Lincolnshire's SEND Local Offer, early years inclusion funding supports the government's strategy by enabling early intervention and removing barriers to learning faced by children with SEND.

EYCC offers access to support in order to deliver the requirements of the Early Years Foundation Stage (EYFS) Framework, this enables providers to effectively meet the needs of children and has a particular emphasis on the most disadvantaged and vulnerable, in order to reduce inequalities in child development, early education and promote the school readiness agenda.



Since September 2014, all new early years providers are able to deliver the early years entitlement upon opening. This supports the sufficiency duty for EYE funded places. To underpin this, a programme of support is available to new providers to give them the best chance of achieving a 'good or better' Ofsted judgement at their first inspection, and thus maintaining a sufficient supply of good quality funded childcare places.

Following their first inspection and beyond where Ofsted judgements are less than good the Targeted Quality Support Programme is available and this is in addition to the quality training courses offered through the <u>Early Years Training Directory</u>. Lincolnshire's online Early Years Training Directory offers access to a comprehensive programme of statutory courses that assist the sector to fulfil EYFS and Ofsted requirements, and to maintain high quality provision.

Lincolnshire has one of the best performing Children Services in the country and we want to fulfil our ambition to ensure that every child reaches their potential and is ready for school. There are a range of services available to support families, from universal services to specialist support, for our families with the greatest need and our most vulnerable children. Information can be found within our **Putting Children First** document on how to access the support available to children and families at times when they need it and advice on how professionals can work collaboratively to better meet the needs of children.

There is extensive evidence that working with children and families at the earliest opportunity, has the greatest impact on their outcomes. Lincolnshire offers support to families through a network of children's centres. The quality and uptake of these services is one of the responsibilities for the Service Manager for early years.
